WEST VIRGINIA PROPERTY TAX LAW REOUIRES ANY INDIVIDUAL OR FIRM IN ANY TRADE OR BUSINESS TO MAKE A WRITTEN REPORT ANNUALLY TO THE COUNTY ASSESSOR WITHIN THE COUNTY THE BUSINESS IS LOCATED/CONDUCTED. THE REPORT MUST SHOW THE COST OF INVENTORY AS OF JULY 1st, 2023.

THE ASSESSED VALUE WILL BE SIXTY PERCENT (60%) OF THE REPORTED INVENTORY COST. THE ASSESSED VALUE IS MULTIPLIED BY THE APPROPRIATE TAX LEVY RATE, TO GET YOUR ASSESSED TAX FIGURES FOR 2022, BUSINESS PERSONAL PROPERTY TAX (see example). THE TAX LEVY RATES USED IN THIS CALCULATION WILL BE ESTABLISHED BY THE LEVYING BODIES IN APRIL OF 2023. THE SUBSEQUENT TAX STATEMENTS WILL THEN BE ISSUED IN MID-JULY. 2023.

EXAMPLE USING THE CURRENT TAX RATE FOR THE CITY OF MARTINSBURG-3.0326 PER \$100 ASSESSMENT--AND A REPORTED INVENTORY COST OF \$1000, THE TAX AMOUNT WOULD BE CALCULATED AS FOLLOWS:

> \$1000 X 60% = \$600 ASSESSMENT \$600 X 3.0326 = \$18.20 TAX AMOUNT
